## MINUTES

**Call to Order** – Muskegon County Persecutor, DJ Hilson called the meeting to order and introductions were made. Members approved the minutes from the May meeting.

**Budget** – Health Project staff noted that June 15<sup>th</sup> is the last day to submit Compliance Checks for Alcohol Retail Retailers. Health Project has received Compliance Check forms from Roosevelt PD, County, Fruitport, Norton Shores PD, and City of Muskegon. Please submit an invoice and the completed compliance check forms to Laura Fitzpatrick or Rachel McCoy at the Health Project.

**Law Enforcement Update** – Compliance Check Press Release is to be completed after June 15<sup>th</sup> once all compliance checks are completed. The Health Project will be releasing the press release.

**Party Patrol** – Health Project staff will be finalizing budgets soon to determine if there is left over funding to support the upcoming Silent Observer/Party Patrol Summer Campaign.

**2016/2017 Marketing Committee** – Rachel announced that because the Muskegon ALI will not be meeting in July that ALI's Marketing Committee will be meeting in July to discuss feature campaign. Jon DeMol, Sarah De La Rosa, Ken Sanford noted that the 15<sup>th</sup> of July is a good day to meet. Rachel is to check with Jared on location and time. Rachel will also send out an invite to the group. DJ Hilson asked Dave Nelson to assist with the Rotary Club at North Muskegon High School for their input in this year's campaign.

**School Outreach** – The upcoming Alcohol Collegiate Awareness events were discussed to get a head start on planning. The County, City, and Township participate with drunk driving

**Ride with Pride Replication** - Health Project staff noted that several schools have expressed interest in this year's Ride with Pride Replication for their school districts. Holton High School has contacted ALI with interest in participating in this year's program. A meeting with Dan Bolhuis (Principal at Orchard View), Jennifer Bustard, Jared Passchier and Muskegon Township will be put together to discuss Orchard View's possible involvement with the Ride with Pride Replication. Fruitport was also discussed, but further communication needs to be done to discuss details.

**Member Agreement Form**- Muskegon ALI members were given a Coalition Involvement Agreement Form (CIA). The CIA Form is needed from all coalitions for state and federal purposes. The form explains a member's involvement with the Coalition for a Drug Free Muskegon County. The signature represents an understanding of roles, purpose, and participation of the DFC coalitions such as; Muskegon ALI.

**Other Good and Welfare** – DJ Hilson noted that the legalization Marijuana vote in Lansing is struggling to pass.
