## **DFMC Executive Committee**

The Executive Committee is made up of the DFMC Chair, DFMC Vice-Chair, DFMC subcommittee Chairs and Coalition staff. The purpose of this group is to develop the policies and protocols for the Coalition as well as to recruit new members and to make sure the Coalition has broad representation that represents the at large community. The Executive Committee also provides leadership in strategic planning along with managing the overall budget and finances for the Coalition and the sub-committees to ensure sustainability of the Coalition as it promotes and fulfills its vision and mission.

## **DFMC Data Committee**

The DFMC Data Committee is made up of DFMC Coalition Chairs and members that specialize in data and evaluation processes. The DFMC Data Committee currently oversees the Michigan for a Profile Healthy Youth (MiPHY) Survey that is administered to 7th, 9th, and 11th grade students in participating public and private schools. The committee works to evaluate and to provide feedback to action teams, so that DFMC and it's sub-committees can achieve positive outcomes from projects and initiatives.





As a group of law enforcement officers and concerned citizens, ALI's mission is to reduce underage drinking and alcohol-related injuries in Muskegon County. ALI believes that giving teens and parents the facts about drinking and encouraging constructive choices will lead to a happier, safer, and healthier community.

## Our mission is to reduce substance use disorder in Muskegon County through education, prevention, and treatment.

In the summer of 2017, over 40 agency leaders, professionals, parents, and citizens from Muskegon County came together to develop the Coalition for a Drug Free Muskegon's third long term strategic plan. The Coalition has dramatically influenced community level outcomes in reducing youth substance abuse in the past ten years and is committed to continuing these efforts. Using the Strategic Prevention Framework (SPF) planning process, the Coalition's next five-year plan calls for multiple initiatives and efforts to reduce the use and abuse of substances among area youth and adults.

The SPF process utilizes the most recent community data, leverages partnerships, and enhances community level decision making with a focus on six main goals:

- Reduce tobacco use pregnant women
- Reduce tobacco use among teens, including electronic vaping products
- Reduce alcohol use among teens and binge drinking among young adults
- Reduce marijuana use among teens
- Reduce opioid related drug overdose deaths
- Increase access to substance use disorder treatment

In addition, Coalition membership has developed multiple objectives and strategies to support the overarching goals. It is the collective hope that county leaders, businesses, parents, faithbased leaders, youth, and residents will respond to this plan of action and help reduce the impact of substance abuse in Muskegon County.
